Share the Road Safely with Big Rigs

Trucking keeps finished products and raw materials moving fast 24 hours a day. These big rigs account for nearly 70% of the total freight moved in the U.S. and generate revenue of more than \$255 billion each year. Hampton Roads is the East Coast's third-largest container port, handling over 24 million tons of cargo.

Truck traffic accounts for 3% and from the ports 10% of all weekday travel on the major roadways, in Hampton Roads. In 2010, approximately 17,000 trucks passed through the Top 10 gateways of Hampton Roads each weekday, this is 16% lower than 2009 prior to the onset



of the recession in the US. Based on the Traffic Impact of an Inland Port of Hampton Roads Study conducted by the Transportation Planning Organization I-64 carries the majority of truck traffic in Hampton Roads followed by Route 58 and Route 460 leading to the Southwestern & Southeastern Areas of Virginia.

But all these miles traveled in vehicles weighing five tons or more inevitably causes trucking accidents. The National Highway Traffic Safety Administration (NHTSA) reports that fatalities from big rig accidents involving large trucks increased by 4% in 2012, and injuries were up by even more – 18%! Not surprisingly, the vast majority – 73% – of deaths and injuries involved occupants of other vehicles. In Virginia, the Virginia Highway Safety Office reported in the 2013 Virginia Traffic Crash Facts 95 occupants were killed in Virginia in accidents involving commercial vehicles or 12.8% of all traffic fatalities and 3,079 were injured.

Causes of Trucking Accidents

Although most big rig drivers are alert and experienced, *driver error* is a major cause of trucking accidents, including:

- Driving too fast
- Driver fatigue or sleep deprivation
- Straying from lane
- Excessive speed
- Following other vehicles too closely
- Driver inexperience or inadequate training
- Driving under the influence of prescription or over-the-counter drugs

Other causes may be the responsibility of the manufacturer or the trucking company:

- Tire failure including inadequate tread depth or mismatched tires
- Brake defects caused during manufacturing or by poor maintenance
- Improper load distribution
- Poor road and weather conditions
- Other equipment failure

Give 'Em a Break!

Trucks take longer to stop, accelerate and turn, and drivers may have limited visibility because of their size and shape. Give a trucker a break when sharing the road:

- Don't merge into traffic or change lanes abruptly in front of a truck.
- Give trucks adequate room when passing.
- Change lanes or slow down to let a slow-moving truck enter a highway.
- Don't pass a truck on the right if that truck is turning right.

What should you do if your car is subject to a recall?

Recently, Automakers are recalling vehicles that have safety related defects almost daily. Vehicle recalls are at their highest in almost a decade, with nearly 22 million vehicles flagged for safety issues last year alone, according to the National Highway Traffic Safety Administration. Some of these recalls have happened in wake of consumers getting in serious accidents and sometimes death. In June 2014, Attorney Paul Hernandez shared insight on the Hampton Roads Show Legal Matters Segment on What to do



if your car is recalled? Here is some of the information he shared.

What is a recall?

An auto recall occurs when a manufacturer (or the NHTSA) determines that a car model has a safety-related defect or does not comply with a federal safety standard. Remember they are for defects that are safety problems. If you're A/C or radio does not work that is not considered a safety defect.

How Notified?

Car Companies are required to inform you by mail. You want to make sure you keep your address updated at your car dealer. However, if you go to NHTSA you can sign up for email alerts

What should you do if your car is subject to a recall? First don't panic. The letter should have instructions on what to do depending on the subject of the recall, if you have questions, call the Dealer.

If Tires are recalled, you only have 60 days from the date of the letter to get them repaired or replaced.

Who pays for repair? The manufacturer is required to pay for the repair of the defective item.

What if I paid for the repair BEFORE there was a recall?

Children should have adult supervision for trick-or-treating.


